## 申請入會和退會須知

### (一) 申請入會及退會政策

1. 凡符合本會入會資格者皆可申請入會。
2. 本會全年均接納入會及退會申請。如申請人未合符入會資格，本會盡快將通知申請人。

### (二) 會員類別和申請資格

2024年1月31日未續會的會員，須從新申請入會，新會員需繳交會員註冊費 HK\$100 及年費 HK\$200。

#### 會員註冊費 HK\$100

會籍共分為三大類別，各項申請資格及每年費用資料如下：

1. 普通會員	贊同本會宗旨及有興趣參與本會工作及活動任何年齡人士。 (會籍期限為一年：2024年1月1日至12月31日)	HK\$200
2. 學生會員	贊同本會宗旨及有興趣參與本會工作，持有本地學生證明文件之會員，年齡為十八歲以下。(會籍期限為一年：2024年1月1日至12月31日)	HK\$50 (免會員註冊費)
3. 永久會員	(1) 贊同本會宗旨及有興趣參與本會工作及活動任何年齡人士。 (2) 需已連續三年或以上成為普通會員。 (4) 持有香港居民身份證三年或以上。 (3) 以書面提出申請後，並通過執委會的批准。	HK\$2,000

### (三) 入會及退會手續

#### A. 普通會員

1. 將填妥會員登記表，親自遞交、郵寄至本會。
2. 本會有權要求首次申請人提交身份證明文件作核對用途，有關副本於核對後將立即銷毀。
3. 如申請人為殘疾人士，則需提供殘疾證明：如殘疾人士登記證、殘疾駕駛許可證或其他證明文件。
4. 入會申請表將交由秘書處審批。
5. 如欲退出本會，會員或其親友請與本會職員聯絡，或以書面通知退會申請。已繳交之會費將不獲退還。

#### B. 學生會員

1. 持有本學生證明文件，年齡為十八歲以下，均可申請成為學生會員；而為方便同時更新會員個人之資料，申請人需再次填妥會員登記表及遞交有關證明文件。
2. 如欲退出本會，會員或其親友請與本會職員聯絡，或以書面通知退會申請。已繳交之會費將不獲退還。

#### C. 永久會員

1. 永久會員擁有選舉權及被選舉之權利。
2. 可優先報名參與本會活動。
3. 如欲退出本會，會員或其親友請與本會職員聯絡，或以書面通知退會申請。已繳交之會費將不獲退還。

### (四) 暫停及終止會籍

1. 如會員違反會章，執委會擁有終止會員會籍之權力，以保障本會之利益及名譽。
2. 會員如若未事先經本會批准，參與其他團體的健力賽(包括但不限於 USAPL, IPL, HKPF, GPA, GPC, IPO, WDFPL, WPA, WPC, WUAP)，即使該會員曾繳交會員會費，亦會被視為放棄 HKWPA 會籍。

### (五) 會員義務

所有會員應盡以下義務及守則：

- a. 盡力推動本會宗旨，遵守規則；及
- b. 會員不得從事有損害本會聲譽及利益的事情；否則本會有權開除其會籍並保留追究權利。

## **Information for membership application and termination**

### **(1) Policy for the application and termination of membership**

1. Anyone who meets the membership qualifications can apply for membership.
2. HKWPA accepts applications for membership and termination throughout the year. If the applicant is not eligible for membership, HKWPA will notify the applicant as soon as possible.

### **(2) Membership categories and application eligibility**

Members who renew their membership after 31<sup>ST</sup> January, 2024 will consider as apply for new membership. New applicants must pay membership registration fee \$100 and annual membership fee \$200.

#### **Membership registration Fee HKD\$100**

(Applicant who are not HKWPA member in 2024 must pay the Membership Registration Fee, Starting from 1<sup>st</sup> January, 2024)

Membership is divided into three types. The application eligibility and fees are as follows:

<b>Membership Category</b>	<b>Application Eligibility</b>	<b>Annual membership fee</b>
Ordinary member	Anyone who agrees with the purpose of HKWPA and is interested in participating in the work and activities of HKWPA. (Membership validity is one calendar year - 1 <sup>st</sup> January to 31 <sup>st</sup> December, 2024)	HK\$200
Student member	Anyone who agree with the purpose of HKWPA and are interested in participating in the work of HKWPA. Student Member needs to hold a valid local student certification documents and under the age of 18. (Membership validity is one calendar year – 1 <sup>st</sup> January to 31 <sup>st</sup> December, 2024)	HK\$50 (Exempt from membership registration fee)
Permanent member	(1) Anyone of any age who agrees with the purpose of HKWPA and is interested in participating in the work and activities of HKWPA. (2) Must have been an ordinary member for three consecutive years or more. (4) Hold a valid Hong Kong Identity Card for three years or more. (3) After the application is submitted in writing and approved by the HKWPA Executive Committee.	HK\$2,000

### **(3) Membership application and termination procedures:**

#### **A. Ordinary members**

1. Complete the membership registration form and submit it in person or send mail to HKWPA.
2. The Association reserves the right to require first-time applicants to submit identification documents for verification purposes. The relevant document copies will be destroyed immediately after verification.
3. If the applicant is a person with disabilities, proof of disability is required: such as a registration card for persons with disabilities, a disabled driving permit or other supporting documents.
4. The application form for membership will be transferred to the HKWPA Secretariat for approval.
5. If you want to withdraw from the association, member or their relatives and friends should contact HKWPA staff or notify the termination in writing. Membership fees paid will not be refunded.

#### **B. Student Membership**

1. Students under the age of 18 with a valid local student certification document can apply to become a student member; in order to update the personal information, the applicant needs to fill in the membership registration form and submit the relevant certification documents again.
2. If you want to withdraw from the association, member or their relatives and friends should contact HKWPA staff or notify the termination in writing. Membership fees paid will not be refunded.

#### **C. Permanent Membership**

1. Permanent members have the right to vote and be elected.
2. Priority can be given to register to participate in the activities of HKWPA.
3. If you want to withdraw from the association, member or their relatives and friends should contact HKWPA staff or notify the termination in writing. Membership fees paid will not be refunded.

**(4) Suspension and termination of membership**

1. If a member violates the Articles of Association of HKWPA, the executive committee has the right to terminate the membership to protect the interests and reputation of HKWPA.
2. If a member participates in competitions organized by other Associations/Groups (including but not limited to USAPL, IPL, HKPF, GPA, GPC, IPO, WDFPL, WPA, WPC, WUAP) without the prior approval of HKWPA, even if the member has paid the membership dues, it will be considered as abandoning the memberships of HKWPA voluntarily.

**(5) Member Obligations**

All members shall fulfill the following obligations and rules:

- a. Make every effort to promote the purpose of HKWPA and abide by the rules; and
- b. Members shall not engage in things that damage the reputation and interests of HKWPA; otherwise, HKWPA reserves the right to terminate their membership and reserves the right to pursue.
